MEDICAID SECTION 1115 SUBSTANCE USE DISORDER DEMONSTRATIONS

Summary of Updates to the Technical Specifications for Monitoring Metrics (Version 5.0) September 2022

This document provides a summary of updates to the section 1115 substance use disorder (SUD) metrics technical specifications manual, released in September 2022 (Version 5.0). This release reflects annual updates from national measure stewards of established quality measures included in the SUD metrics. Additionally, this release incorporates clarifications and improvements to metrics reporting guidance and specifications for CMS-constructed metrics, reflecting the valuable feedback shared by states during review and use of the technical specifications manual.

CMS will update the technical specifications manual annually to provide current specifications and value sets. As described in the technical specifications manual, Table 1 below outlines the manual versions the statue should use:
